# **Expanding Our Impact**

onvener and connector, words often used to describe GSBA. Being known as a business  $\smile$  organization that brings ideas and people together has resulted in GSBA being approached by many organizations, elected officials and businesses throughout the Puget Sound region and across the country, asking for our leadership, support and endorsement. Often, the only voice advocating for small businesses, especially with our unique perspective of viewing business through a social justice lens, GSBA is experiencing great growth. Our challenge is to evaluate how to effectively grow our sphere of influence.

The GSBA Board has been discussing growth in terms of geography and whether GSBA should be representing a wider expanse of our region and state. In trying to understand the impact of growth, we were struck by the obvious: we are already a statewide organization. as evidenced by our statewide Scholarship Fund, our LGBT tourism initiative and our policy work advocating for equality in business. As we expand to meet our increased responsibilities and workload, GSBA has increased its staff and rented a second office in our building to accommodate our larger staff.

At this time, representing our state does not translate into expansion of a bricks and mortar presence but we do need to have a conscious commitment to understand the impact our decisions have across the state. Expansion for GSBA is not limited to geographic growth but increasing the depth of work we already do. Our programming, while still focused on the needs of small businesses, now includes designing programs that provide economic development opportunities for our members. The Scholarship Fund is not simply giving out more scholarships, it is deepening our support to ensure that our scholars can complete their degrees. These are exciting times for GSBA, our members, and our community as we grow and expand to meet the challenges faced by business and nonprofit leaders committed to community, equality and inclusion. Working together, we are confident we will meet today's challenges and we are excited for our future.



# Innovation and Partnership

re LGBT specific cruises, resorts and tours still sought after vacations for the LGBT community? With changing laws and an evolving world, are members of the LGBT community shifting their vacation choices to mainstream cruises and resort areas? How has the marketing of and messaging around these types of vacations changed to reach new audiences? To answer those questions, GSBA invited Judy Dlugacz, human rights pioneer and entrepreneur, to speak at our annual Travel and Tourism Luncheon.

In 1973, and with nine partners. Judy took a leap of faith and founded Olivia Records, which grew to become one of the industry's leading independent small labels. Judy produced 40 albums and sold more than one million records by artists such as Cris Williamson, Meg Christian, Teresa Trull, and Linda Tillery. Judy's vision and evolution continued when, in 1990. she combined two of her passions—music and travel—by hosting a "concert on a cruise." She invited women to enjoy the performances of Olivia Records artists and scheduled activities on a completely chartered ship. The response was so overwhelming that she founded a company offering vacations exclusively created for women, Olivia Travel, which has today become the premier travel company for the lesbian community, with a 98% satisfaction rating from its guests.

# Obergefell v. **Hodges**

In March 2015, GSBA led the national business community in an amicus brief in the Obergefell v. Hodges case.

The US Supreme Court examined the nature of fundamental rights guaranteed to all by the Constitution and the evolving understanding of discrimination and inequality.

In June 2015, the Court held in a 5-4 decision that the fundamental right to marry is guaranteed to same-sex couples

> by both the Due **Process Clause** and the Equal **Protection Clause** of the Fourteenth Amendment to the United States Constitution. Consequently, all remaining bans on the performance and recognition of samesex marriages were struck down.

Prior to the case, thirty-eight states and territories already issued marriage licenses to same-sex couples.






